

**Agreement on the use of materials and services of the website apicenna.ru  
(user agreement)**

This Agreement is a public offer and it defines the terms and conditions of use of materials and services posted on the website at the address: apicenna.ru, by visitors and users of this website (hereinafter - the Website).

**1. General terms and conditions**

1.1. The website was created to inform users about the terms and conditions of cooperation with Apicenna, LLC, as well as for the purpose of selling products from the range of Apicenna, LLC.

1.2. The website contains informational materials about Apicenna, LLC and the brands and products represented in the Apicenna, LLC range.

1.3. The use of the materials and services of the Website is regulated by the norms of the current legislation of the Russian Federation.

1.4. To get access to the materials of the Website the User shall log in to the website apicenna.ru. To receive personalized information, you shall log in to your personal account on the website apicenna.ru.

1.5. By accessing the materials on the Website, the User shall be deemed to have adhered to this Agreement.

1.6. The User can use the materials of the Website and the services provided on the Website only with the indication of the URL link to the website apicenna.ru.

**2. User responsibilities**

2.1. The User agrees not to take actions and not to leave comments and records that may be considered as violating the Russian legislation or norms of international law, including in the field of intellectual property, copyright and/or related rights, generally accepted norms of morality and ethics, as well as any actions that lead or may lead to disruption of the normal operation of the Website and Website services.

2.2. The use of materials of the Website without the consent of the right holders is not allowed.

2.3. When quoting materials from the Website, including protected works of authorship, a link to the Website is mandatory.

2.4. The Website Administration is not responsible for visiting and using external resources, links to which may be contained on the Website.

2.5. The Website Administration is not liable and has no direct or indirect responsibilities to the User in connection with any possible or arisen losses or damages related to any content of the Website, copyright registration and information on such registration, goods or services available on or obtained through external websites or resources or other contacts of the User, in which they entered using the information posted on the Website or links to external resources.

2.6. The User agrees that the Website Administration does not bear any responsibility and does not have any responsibilities in connection with advertising that may be placed on the Website.

### **3. Other terms and conditions**

3.1. All possible disputes arising out of or related to this Agreement shall be resolved in accordance with the current legislation of the Russian Federation.

3.2. The invalidity or unenforceability of any provision of the Agreement by the court shall not invalidate other provisions of the Agreement.

3.3. Inaction on the part of the Website Administration in case of violation of the Agreement provisions by any of the Users does not deprive the Website Administration of the right to take appropriate actions later in defense of its interests and protection of copyrights to the materials of the Website protected in accordance with the legislation, which may be expressed in violation of the algorithm of functioning of the Website by the Users (by hacking the code of the Website).

3.4. The Website Administration has the right to unilaterally change the terms and conditions of this Agreement at any time. Such changes shall be effective 1 day after the new version of the Agreement is posted on the website. If the User does not agree with the changes made, they shall refuse access to the Website, stop using the materials and services of the Website.
